RLG clients include financial sponsors and their portfolio companies, corporations, governments and sovereign wealth funds and pre-IPO high growth companies.

- Assist in managing transactions and driving execution
- Participating in internal capital committee approval processes, including contributing to committee memos and attending preparatory briefings and the relevant committee meeting as required to ensure that any documentation, structural and/or transaction risks are appropriately reflected and approved
